Further to your request for information, the University's response is below:

The University believes that this information is personal information and is therefore exempt under Section 40(2) of the FOIA. Section 40 (2) of FOIA provides an exemption where the application for personal data is made by someone other than the data subject. To apply the exemption appropriately, the conditions set out in Section 40 (3) of the FOIA should be satisfied. Section 40 (3) of FOIA states that where disclosure of the information would contravene any one of the eight principles in the DPA then this data is exempt.

The University does not believe that the release of the data requested will be fair or lawful to the individuals under the terms of FOIA as the data subjects have no expectation that their

personal data is likely to be released for this purpose and, as such, disclosure of the information requested by you under Section 1(1) of the FOIA would be in breach of Principle 1 of the DPA and hence section 40 (2) of the DPA applies.

Please note that the University has a formal complaints procedure. If you are unhappy with the service you have received in relation to your request and wish to make a complaint or request a review of our decision you should write to the University's Governance Services in the first instance (info-compliance@bangor.ac.uk) explaining the grounds for your complaint. In line with guidance from the Information Commissioner's Office, an appeal request must be submitted within 40 working days of the University's final response to this Freedom of Information Act request.
