My name is _____. This FOI request relates to the university's Confucius Institute, in particular to the roles at the Confucius Institute for which individuals are recruited in China (if I understand correctly, that is the Chinese language teachers, and the 'Chinese co-director').

• Are these university roles? Are the rights and privileges of university staff attached to these roles? Are those who occupy these roles staff of the university? Are these individuals employed by the university? Please share any documentation that answers these questions or otherwise defines the legal status of these roles and those who occupy them.

All staff recruited from China by the SCIBC are seconded staff authorised via Tier 5 Certificates of Sponsorship. They therefore have access to services to facilitate the use of essential IT systems which allows them to perform their learning and teaching duties such as email, file storage, the virtual learning environment, printers and the library. They are treated in a similar way to visiting scholars and managed in accordance with relevant HR policies. For information we have attached a copy of our Visiting Scholar Guidelines which are available within the Learning and Teaching policies page on our website.

All secondees are inducted via relevant training and are expected to uphold and abide by the University's formal Values and Strategy. You can view further information regarding our Values and Strategy here: https://strategy2025.hw.ac.uk/

As above, all visas are issued in London and applications are via the Chinese International Education Foundation (the successor body to Hanban).
