Good morning and thank you for your e mails. I'm afraid I can't keep up, so I apologise for not answering them all. But please be assured that the team here is getting a supply of ventilators and PPE back to the UK, mostly purchased, and some donated, bringing ventilator components on stream for Chinese ventilator manufacturers (unblocking their supply chain problems) and looking ahead to supply future NHS needs. So far, HMG's purchases from China account for over 90% of ventilators delivered to the NHS.

We know there are many people offering to help and we leave no stone unturned. But we are not in a position to sign anything except contracts for verified purchases. We are not dealing in letters of intent and MOUs. I'm afraid.

The Chancellor had a positive conversation with Vice Premier Hu Chunhua yesterday building on the PM's two conversations with President Xi.

Meanwhile, if you are able to access your membership from your phone, I wonder if you and the 48 Group would be able to support this initiative which we are taking with others, including the CBBC, British Chamber and CBI, to help companies get supplies through Chinese customs and on to planes back to the UK.

I wonder if you would be able to post a notice and the attachments prominently on your websites or circulate the following to your members (whichever works) along the following lines:

CUSTOMS CLEARANCE AND SHIPPING URGENT MEDICAL EQUIPMENT FROM CHINA

The British Embassy, Beijing, is aware that many companies are having difficulties clearing Chinese customs and shipping urgent medical equipment purchased in China. We have drawn up and attached a checklist of necessary **customs clearances** that companies **need** to secure during equipment procurement (PDF att).

If a company has a very **small volume** to **ship**, in the first instance please note that a number of agents including DHL are still operating in China.

If that route does not prove fruitful and if the small package is urgent, the Embassy can try to include it onto flights being chartered for centrally procured equipment for the NHS and DHSC. This will depend on available space and an understanding that HMG-procured equipment will take priority on these flights. In this case, please contact: <redact> If companies are trying to **ship equipment in large volumes**, the Embassy recommends that they charter a flight. DHL is still working and other carriers, including Cathy Pacific, have also offered cargo routes. Please see attached "Quick Guide".

The background is that, alongside the substantial amounts of equipment on planes that we are chartering, we are receiving requests from companies which we would like to help but which are currently disrupting the urgent flow of equipment we are shipping back to the NHS.

Thank you for your email. I wanted to give you a sense of UK support so far for China's response to the COVID-19 outbreak. The UK stands ready, together with international partners, to continue supporting the Chinese authorities as they deal with this public health emergency of international concern.

The UK has delivered essential medical supplies to Chinese hospitals and healthcare workers, including over 430,000 gloves and over 58,000 wipes, gowns and goggles. has also donated over £50 million in support of tackling the epidemic. This includes the Department of Health and Social Care providing £20m to fund vaccine research; the UK's Wellcome Trust (in partnership with the Department for International Development) providing £10m to accelerate research and support for global efforts; and UK Research and Innovation's Medical Research Council allocating £20m for an initiative inviting researchers to submit proposals for projects to develop vaccines, therapeutics, diagnostics or address the epidemiology, spread or underpinning knowledge of COVID-19.

The UK has also offered specialist medical support via WHO and bio mathematical modelling support to Chinese data specialists.

Most recently, the UK responded to the World Health Organisation's (WHO) Flash Appeal to stop the spread of the disease, providing £5 million to support the developing countries most at risk of coronavirus to quickly identify cases and care for patients.

I am also in touch with British Business in China through the Chamber, CBI and CBBC. Please do let me know of any issues you hear about from the 48 Group.

The British Council has been liaising with education institutions in the UK, keeping them updated on developments in China, and also supporting queries from Chinese students and agents to minimise applications and enrolment disruptions. They continue to provide practical, on the ground support for UK examining bodies working in China, who are hoping to restart testing for Chinese test takers as soon as possible.

Many British companies and sister-cities have already made financial or in-kind donations to China. We are now working with the British Chamber, CBBC, and CBI to see what more we can do to help match supply with urgent needs, to facilitate logistics and to provide guidance to the many more British businesses and institutions who want to help but aren't sure of the best way to do so.

As the crisis unfolds, the UK will continue to explore ways in which our world-leading research base can collaborate with China and other international partners to bring this global health challenge under control.

Good to see you on the BritCham China & Italy collaboration call yesterday. Thank you for the great endeavours being made by your teams to work through this most complex of situations.

I wanted to flag with you an offer of 10,000 protective masks to the UK put forward to The 48 Group by a Chinese organisation fronting a Silk Road NGO network known as Sironet (background attached).

In order to be joined up in the UK's COVID-19 response and to support the proactive measures to source PPE from China, <redact> recommended that I contact you in the first instance. Images of the product and packaging also attached.

NB – <redact> Sironet recently hosted bilateral virtual conferences on the virus with a number of developing nations, and those charged with monitoring and treating refugees, to share their experience. On these video conferences they showcased the experiences of two doctors from Shanghai Minhang TCM Hospital (one is chief physician in respiratory Department, who is in charge of detect and assess suspected cases, the other a physician in the emergency department who treated critical patients) alongside a doctor and a nurse from Shanxi Bethune Hospital, both of them were sent to Wuhan and were working on the frontline.

Please let me know if you would like me to direct this offer to you or a colleague at DIT working on collating and transporting PPE from China.
