I took away from Friday an action to find out the authenticity of the document from the Chinese Ambassador that had been shared with Stanley Johnson, and Stanley called me Saturday. Attached are a full document set – two letters Stanley received from the Chinese Ambassador in August, the talking points Stanley had for his meeting, and the response from the Chinese Ambassador. I've copied below the section on "China supports tackling deforestation in supply chains". My question -I think mainly for [Redacted] is whether – from a policy perspective – if there is anything new in the statement below. The title suggests a proactive position, although the substance focuses just on illegal timber.

Stanley is meeting the Ambassador again on Wednesday at 4pm in London. This could be an opportunity to (1) socialise about the WLS forests event and if China wants to speak; and (2) ask how much further China is willing to go on action on deforestation in supply chains. I presume this is inadvisable, but Stanley is indicating his willingness to help, if appropriate. He has also asked if LZG could come with him (again I presume no).

3. China supports tackling deforestation in supply chains

Forests play an important role in the global carbon cycle. As a responsible

global player, China has been committed to the protection, restoration and

sustainable development of the global forest resources.

 At home, China's achievements in protection and restoration of forest

resources are an important contribution to the global efforts to slow

down the diminishing forest coverage and to restore forests.

 China has also taken an active part in global mutuallybeneficial

cooperation to promote the sustainable development of forest resources.

On timber and other forest commodities

 China has strict regulations on the import of timber and other forest

commodities. We strongly oppose and vigorously crack down on the

illegal logging and trade of timber. The Chinese Government and the

governments of the relevant countries have established cooperation

mechanisms and signed MOUs on this issue.

 The operation of Chinese logging companies abroad and their logging

activities are carried out in accordance with local laws and regulations.

The Chinese Government stands ready to engage in close cooperation

with all the countries, including African countries, to vigorously crack

down on illegal logging and illegal trade of timber.

 We will also uphold the strategy for global cooperation on forest

resources that highlights win-win cooperation and sustainable development, and make greater contribution to maintaining normal

international trade of forest commodities and stepping up protection

of the global forest resources.

I'm conscious you're due to speak to [redacted] at 1330. I'm sure you already have ideas on what to say, but I thought it might be useful to provide a few suggestions. I've also copied below the [redacted].

Suggested points:

Original purpose of the call was to sight you on our plans in advance, but obviously events have now taken over.

Seen [redacted], and understand your strength of feeling. But want to set out in a bit more detail our own thinking and rationale.

While the visit is frankly unwelcome, and the easier choice would have been to disengage, we do see it as a rare chance to communicate frankly to someone who has direct influence over China's policies in Xinjiang just how appalling their actions are, how much damage they're doing to China's reputation globally, and how deep the strength of feeling is in the UK.

CCP officials like Tuniyaz are largely insulated in China form robust, uncomfortable messages, and can become convinced of their own propaganda. This offers a rare chance to cut through that, genuinely make him feel deeply uncomfortable, and face up to hard-hitting evidence of the suffering the CCP has caused.

If the meeting goes ahead – and it is still not confirmed – I intend to use it to hand over satellite imagery, lists of detainees, and confront him with first hand evidence and testimony that we've compiled. Offering a meeting with activists in advance was done in a genuine spirit of transparency and openness.

I know that [redacted] raised concerns this would offer China a propaganda win. But by not engaging, they would immediately spin this as further evidence that we are only willing to hear one side of the story – [redacted]. We need to counter that and show that we are willing to engage. [Redacted]While you may not agree with this approach, I wanted to explain in more detail some of the nuance of our thinking.

Thanks for sharing. I've reached out quickly to close partners here to see if any others are expecting a visit from Tuniyaz and will update when we know more. (<REDACT>).

For a hint as to the positions Tuniyaz might take on a visit to the UK, it might be useful to look at some <u>remarks</u> he made at the Human Rights Council in February 2021, while still vice governor of Xinjiang. A few excerpts:

- On "re-education" camps: "the centers educated and rehabilitated people influence by religious extremism and guilty with minor crimes, in order to prevent them from falling into victims to terrorism and extremism, and maximize effort to protect the citizens' basic human rights from infringement. By October, 2019, all trainees of these facilities had graduated."
- On labour practices: "Xinjiang's labor and employment security policies and practices are fully in line with the Chinese Constitution and laws, the international labor and human rights standards"
- On religion: "Xinjiang protects its people's freedom of religious belief, fully meet the
 faithful's needs for their normal religious activities. Islamic classics and popular books
 have been translated and published, infrastructure conditions for religious venues
 markedly improved and the public service level continuously upgraded."

Plenty still to be unpicked around the rationale for this visit. <REDACT>
Press scrutiny of his programme will mean predictable risks for any official meetings.
<REDACT>. At the same time, this could be our most significant engagement with senior leadership in Xinjiang for a long time (<REDACT> might know exactly how long) so there's an opportunity here for substantive engagement on our human rights concerns. Note: Governors of autonomous regions are now as a rule drawn from the dominant ethnic minority group in the region. This is not to say the Governor is purely a figurehead, but their selection of course serves a significant presentational / propaganda role. Tuniyaz is subordinate to Party Secretary MA Xingrui, who calls the shots.

China: Private prosecution of Governor of Xinjiang

The Attorney General has received a request to consent to a private prosecution against the Governor of Xinjiang, Erkin Tuniyaz, for offences of torture. Media is reporting that the application has been made by the barrister Michael Polak on behalf of Erbakit Otarbay, a Kazakh national and former detainee of a detention camp in Xinjiang, who is now living in the UK. Tuniyaz is currently scheduled to arrive in the UK on or around 13 February (we have not seen confirmation of flight details) for a short visit. This will involve a meeting with an FCDO official, which was the subject of an Urgent Question by Iain Duncan Smith MP earlier today. Protocol Directorate have confirmed to the Attorney General's Office, at their request, that no special mission status certificate (which would confer privileges and immunities) has yet been requested by the Chinese for this visit. Travelling on a diplomatic passport would not provide Tuniyaz with immunity. We understand that the Attorney General's Office will give due consideration to any application for prosecution. Given that news of the request for a private prosecution is now in the public domain, it is possible but by no means certain that China will decide to cancel the visit. Nevertheless, it is important that we do not provide any comment that could prejudice any potential prosecution. We recommend instead directing any press queries to the Attorney General's Office.



Firstly, congratulations on your appointment as Foreign Secretary.

You and the Prime Minister have consistently stressed the importance of fighting for freedom and democracy around the world and it is clear that this will be one of the government's priorities as we address the threats to our security posed by Russia and China. The reception to mark WFD's 30th anniversary, to be hosted by Speaker Hoyle, is an opportunity to reaffirm this and launch a new phase in WFD's relationship with FCDO.

"United with our allies, we will stand up for freedom and democracy around the world - recognising that we can't have security at home without having security abroad."

Prime Minister Truss, 6 September 2022

The UK established WFD in 1992 as a response to the greatest geopolitical event since WW2 – the collapse of the Soviet Union. WFD was founded on British values of democracy, rights, inclusion and tolerance but it did not simply rest on its values. WFD was never just a symbol but instead was conceived in order to take action to support those struggling to live up to the promise of the tectonic shifts that were making freedom possible in Europe and across the world.

It was obvious then that democratic freedoms – our values – were not an optional extra but were in fact the defining feature of the geopolitical divide that we had been living with for a generation. Over time, we and others lost our focus on that geopolitical reality. A globalised



economy masked the importance of those differences in values and gave us the impression that global democracy would inevitably align with global prosperity.

But we were wrong. Geopolitics matters now as much as it did 30, 40 and 50 years ago. It matters because it shapes our understanding of the threats to our national security, as well as of the opportunities for global prosperity. Our democratic values are again, as they always have been, central to our understanding of those threats and opportunities.

By the time of the 19 October event, WFD's new strategy should have been launched, including our commitment to establish a new Centre of Expertise on Elections and Democratic Governance. It would be an honour for us if you would use the reception to speak about the relevance of British values to the struggle for democracy around the world and your ambitions for WFD for the next 30 years.

The format of the event will be a reception from 6.00-8.00pm in the Speaker's apartments for parliamentarians and a small number of others that have been associated with WFD's work. There will be a brief welcome by Mr Speaker and some recorded contributions from WFD's partners, including in Ukraine and Taiwan. Your remarks could be for, say, ten minutes and we could record them and work with the FCDO Communications team to use the remarks in an appropriate way.

I do hope that you will agree to do this as part of the increasingly close and effective working relationship that we enjoy with our FCDO sponsors and colleagues. I am copying this to Anthony Smith, WFD's CEO.

Thank you for your letter of 30 June to the Foreign Secretary about Westminster Foundation for Democracy (WFD). I am replying as the Minister of State responsible for democracy.

Thank you for updating on your plans to hold an event focused on Ukraine's democratic transition. The UK remains fully committed to supporting Ukraine's reform trajectory, including strengthening its democratic institutions and anti-corruption architecture, to ensure it can build back better following Russia's illegal invasion. This forms the core of the UK's offer of support to Ukraine's recovery, as the Foreign Secretary announced at the Ukraine Recovery Conference in Lugano on 4-5 July. However, as the Foreign Secretary set out in her letter of 29 June, we remain unconvinced that now is the right time for such an event. Do please continue to engage with my officials on other areas of potential cooperation on democracy and governance issues in Ukraine

Thank you for inviting the Foreign Secretary to WFD's 30th anniversary celebration in the Speaker's apartments. I hope that we will be in a position to confirm who will attend shortly after recess. I also look forward to reviewing WFD's new strategy before it is published.

Many congratulations on the outcomes of the G7 and NATO Summits. Their statements make clear the urgency of fighting back against autocratic aggression and reinforcing democracy around the world. They also reinforce our determination to raise WFD's ambition for the period of our next strategy, which we will launch in October. With that in mind, I wanted to flag three things to you:

- I want to press the suggestion made in my previous letter, namely that we should build on your Mansion
 House speech by incorporating references to democracy support. There are two reasons for this:
 - First, the evidence is clear that the improved security alliances, economic partnerships and
 investment agreements that we want to offer to wavering countries will be fragile unless we address
 the quality of their democracies. Those countries need accountability, transparency, the rule of law
 and independent media to protect their freedoms and our interests. None of those come
 automatically and we need to help local reformers to tackle the weaknesses.
 - Second, if we don't, Russia and China will step into the vacuum they are already providing very
 significant funding and technical advice to sympathetic political parties, parliaments and media
 organisations across Africa, the Pacific, the Middle East and elsewhere. There are many
 parliaments, parties and electoral bodies that want to work with the UK, but we need to provide
 practical support. We have invited Harriet Mathews to attend the WFD Board meeting on 21 July
 and could discuss this with her then.
- 2. On Ukraine, we are discussing with the FCDO team a possible discreet meeting of Ukrainian MPs with WFD and other organisations that have been supporting the democratic transition there (WFD has been working with the Ukrainian parliament since 2009 and is the only international body that they give office space to). Wilton Park are keen to work with us on this, even if it proves best to meet inside Ukraine. The aim is to start planning how to ensure Ukraine's democracy emerges stronger after the war, tackling the long-standing corruption and other challenges that we and others have been working on for years.
