Please provide this information in aggregated numbers by different programmes. **No degrees have been conferred by the College between 2015-2023**
- Lists of education programmes, research projects, and research grants that are currently operational at Lanzhou University Wales College, either participated by Lanzhou University Wales College students and staff or sponsored by the Lanzhou University Wales College and the University of Wales. The following programmes will be delivered **BA Environment Design; BA Graphic Design/Visual Communication Design; MA Art and Design to be delivered from September 2024**
- University of Wales policies and governance structure which oversee the operations, including student experience and research, at the Lanzhou University Wales College. Please provide relevant policy documents and/or relevant administrative staff role specifications where applicable. **Whilst some policies have been created as part of the Chinese Ministry of Education validation process these are deemed to be commercially confidential and subject to the exemption in s.43 FOIA 2000. Specific role designations are currently taking place and will be published in the future so we would rely on the exemption in s.22 FOIA 2000 (information intended for future publication)**
- From 2015 to 2023, donations, grants, and research fundings received by the University of Wales and its affiliated entities from the Lanzhou University and/or any affiliated individuals, companies, or relevant Chinese official agencies. **There have been no donations, grants and research findings received from the College**
