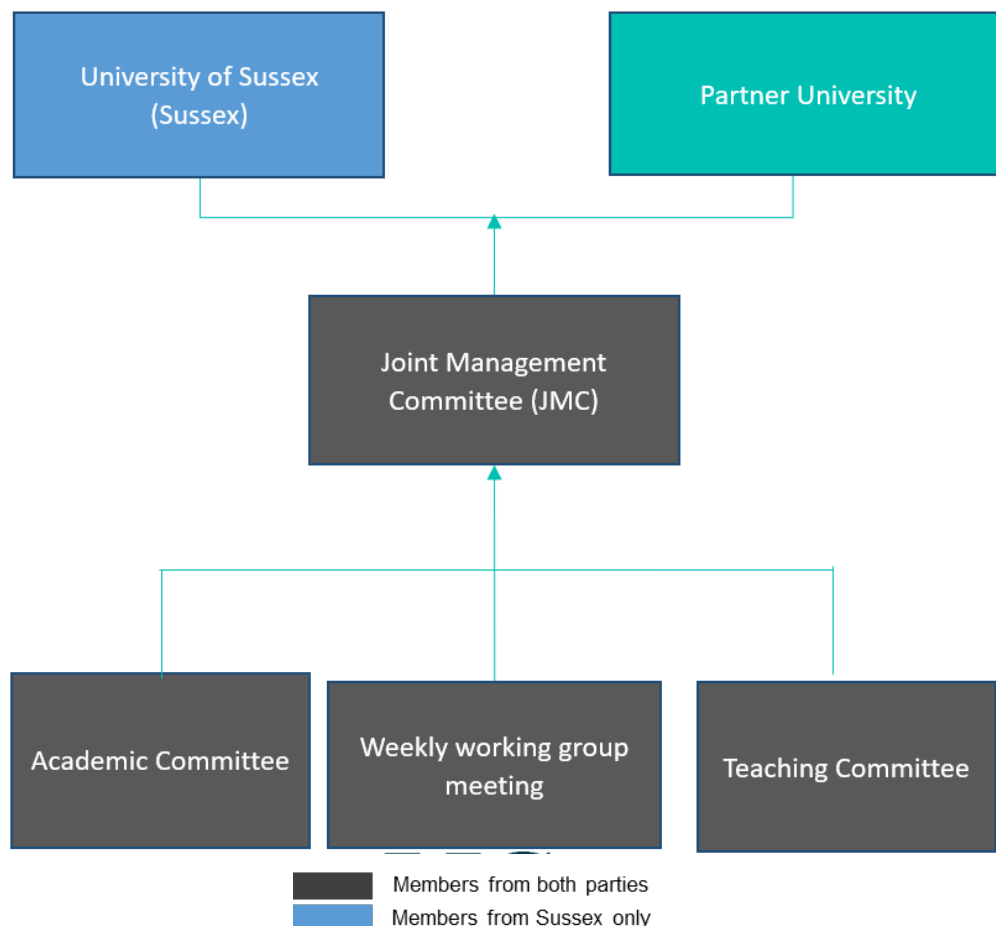


### Current TNE Governance Structure

All of the courses offered at the Sussex Artificial Intelligence Institute are fully integrated into the governance arrangements of the University of Sussex such they are overseen to the same standard of academic rigour and quality. The governance structure for the implementation of our current TNE project at the Sussex Artificial Intelligence Institute, Zhejiang Gongshang University is established in the Charter agreed with our partner alongside other legal documentation establishing the Institute. Following the requirements of the Chinese Ministry of Education, the highest governance authority of the Institute is a bi-annual Joint Management Committee, supported by regular meetings of an Academic Committee and a Teaching Committee. The operation of the TNE project is also supported by a weekly working group meeting between University of Sussex and ZJSU colleagues.
