I am writing in response to your request for information regarding the HBU-UCLan School of Media, Communication and Creative Industries (Ref FOI 3284).

The information you requested is as follows:

- Total annual budget allocated to its directly-affiliated Chinese Communist Party branch by the HBU-UCLan School of Media, Communication and Creative Industries during the years 2015-2023.
- Total annual expenditure spent by the HBU-UCLan School of Media, Communication and tive Industries' Chinese Communist Party branch during the years 2015-2023.

We do not hold this information as UCLan does not have any role in the financial management of the HBU-UCLan School.

HBU-UCLan's approval under the Chinese Ministry of Education (MoE) is as a "Joint Institute" (second level of MoE approval) but purely in academic terms (i.e. it is a partnership in which there is an entity that delivers a dual award in which students receive a degree from both partners and both partners collaborate to do this). This is different from an "University with Independent Status" (top-level of MoE approval) which would be a Joint Venture (JV) company and would involve both parties making joint decisions on how to spend a shared budget.

In a Joint Institute, the estate, finances and management of the financial aspects of the institute is purely the responsibility of the Chinese party (in this case, Hebei University (HBU)) and UCLan only receives a per-student fee for its role in delivery of the programmes. There is no shared budget (outside of, for example, individual small-scale research projects) and all funding for the institute comes from student income paid directly to the partner. UCLan does not have any say in how HBU chooses to spend this money, and so we do not have access to information about budgets or expenditure.

Any questions about these budgets/expenditures should be directed to HBU. However, please be aware that this would be outside the scope of UK Freedom of Information law.
