Re: Freedom of Information (Scotland) Act 2002 – Request for Information

Thank you for your email which was received by the University on 25 April 2023 timed 22:38 hours, and subsequent clarification received 01 May 2023 timed 12:21 hours, requesting the following:

Request:

I am conducting a survey of UK higher educational institutions to find out which have had business dealings with the Chinese genomic sequencing company BGI Genomics.

I would like to ask whether your university has ever had any contracts or business relationships with BGI Genomics or its UK subsidiary MGI Tech UK. If there has been any work undertaken by BGI Genomics with your university, please can you provide a list of these contracts with dates from and to, and a short description of what the contract was for.

Clarification requested:

Can you please advise the time period you wish your request above to cover.

Clarification received:

I would like to clarify that I am requesting information on any contracts with BGI Genomics from 1 January 2015 to 1 May 2023.

University's Response

There is no record of any direct dealings between the University and BGI Genomics or its UK subsidiary MGI Tech UK specifically, in the period requested. Therefore, the University of Glasgow does not hold the information that you have requested and is not aware of any other public authority that could respond to your request. Section 17 of FOISA states that where public authorities receive requests for information that they do not hold, they must issue a notice advising that they do not hold the requested information.

The supply of documents under the terms of the Freedom of Information (Scotland) Act 2002 does not give the applicant or whoever receives the information any right to re-use it in such a way that might infringe the Copyright, Designs and Patents Act 1988 (for example, by making
