I write in response to your request for information received by The University for the Creative Arts (UCA) on 25 February 2024.

In your request you asked to be provided with information in relation to the following:

From 2015 to 2023, the numbers of University for the Creative Arts degrees (including all Bachelor and Master) conferred every year at the Institute of Creativity and Innovation, Xiamen University (Institute of Creativity and Innovation in short). Please provide this information in aggregated numbers by different programmes.

The Institute of Creativity and Innovation (ICI) was established in 2019 as a joint venture institute and recruited its first cohort of students in 2020. As such, no degrees have been conferred to date. The first graduating cohort is due to graduate in June of this year (2024).

The following courses have students due to graduate this year:

Bachelor of Arts (Honours) Environmental Design: 87 students due to graduate in June 2024

Bachelor of Arts (Honours) Visual Communication: 177 students due to graduate in June 2024,

Total: 264 students

Lists of education programmes, research projects, and research grants that are currently operational at Institute of Creativity and Innovation, either participated by Institute of Creativity and

Innovation students and staff or sponsored by the Institute of Creativity and Innovation and the University for the Creative Arts.

The following undergraduate programmes are currently being taught at ICI:

- 2. Bachelor of Arts (Honours) Environmental Design
 - a. Current enrolment: 308 students
- 3. Bachelor of Arts (Honours) Visual Communication
 - a. Current enrolment: 400 students
