Regarding the names of staff and third parties, under the Freedom of Information Act 2000, Section 40 provides an exemption from the duty to disclose information where it constitutes personal data, as defined in the Data Protection Act section 1(1). The information that you have requested may well enable identification of a particular employee or other individual and would therefore constitute personal information.

For your information the Freedom of Information Act S40 personal information exemption says:

- "(1) Any information to which a request for information relates is exempt information if it constitutes personal data of which the applicant is the data subject.
- (2) Any information to which a request for information relates is also exempt information if—
- (a) it constitutes personal data which do not fall within subsection (1), and (b) either the first or the second condition below is satisfied.
- (3) The first condition is—
- (a) in a case where the information falls within any of paragraphs (a) to (d) of the definition of "data" in section 1(1) of the Data Protection Act 1998, that the disclosure of the information to a member of the public otherwise than under this Act would contravene—
- (i) any of the data protection principles, or
- (ii) section 10 of that Act (right to prevent processing likely to cause damage or distress), and
- (b)in any other case, that the disclosure of the information to a member of the public otherwise than under this Act would contravene any of the data protection principles if the exemptions in section 33A(1) of the Data Protection Act 1998 (which relate to manual data held by public authorities) were disregarded.
- (4) The second condition is that by virtue of any provision of Part IV of the Data Protection Act 1998 the information is exempt from section 7(1)(c) of that Act (data subject's right of access to personal data)."

Personal information is exempt from disclosure under Section 40(2) of the Freedom of Information Act if doing so would be unfair and unlawful. In assessing whether disclosure of this personal information would be fair the University considers whether the information is sensitive personal data, the possible consequences of disclosure on the individual concerned, the reasonable expectations of the individual, whether the information has been or remains in the public domain, the FOIA principles of transparency and accountability, and whether there is a legitimate interest in the public or requester having access to the information and the balance between this and the rights and freedoms of the data subjects.

While the information you have requested is not considered sensitive personal data the identification of individuals and their personal information without their consent in cases where confidentiality can be reasonably expected would risk a breach of the first principle of the Data Protection Act 2018. The university therefore believes the S(40)(2) exemption is engaged and will withhold the information in the form that you requested.
